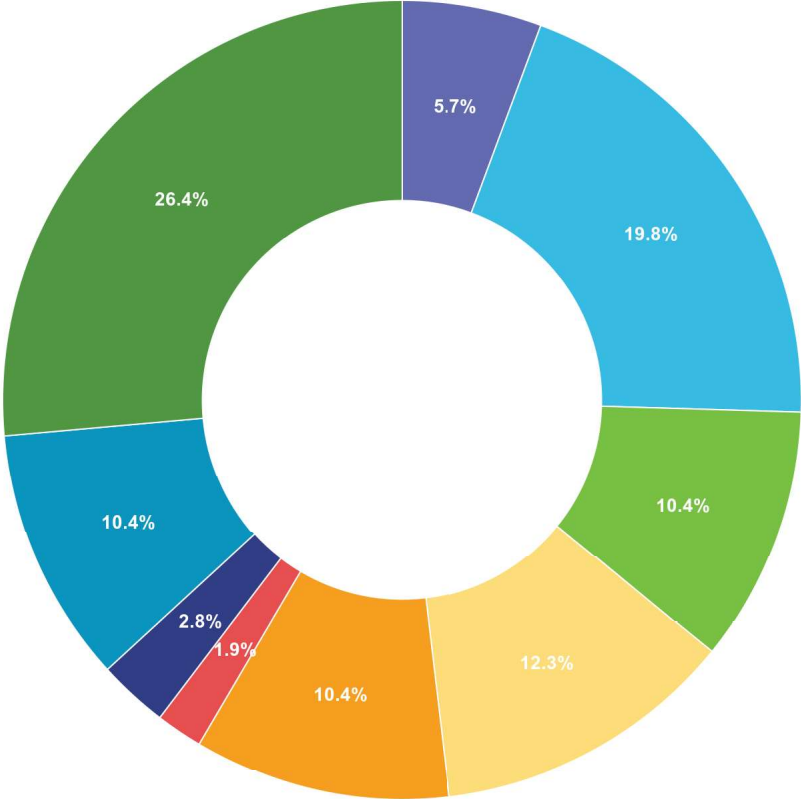




## COVID-19 Business Update

Q1 What industry is your business in?



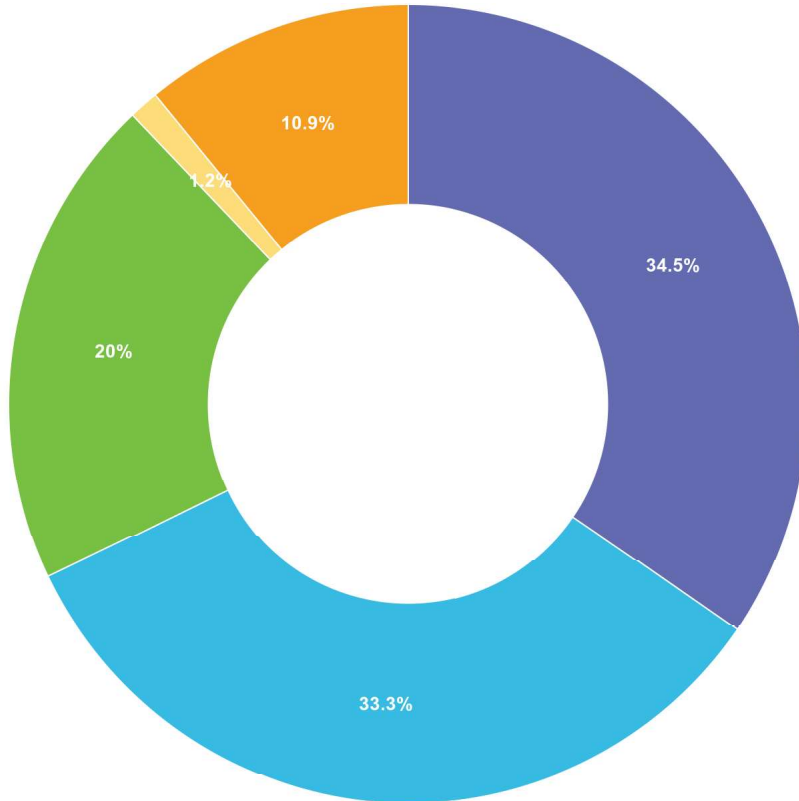

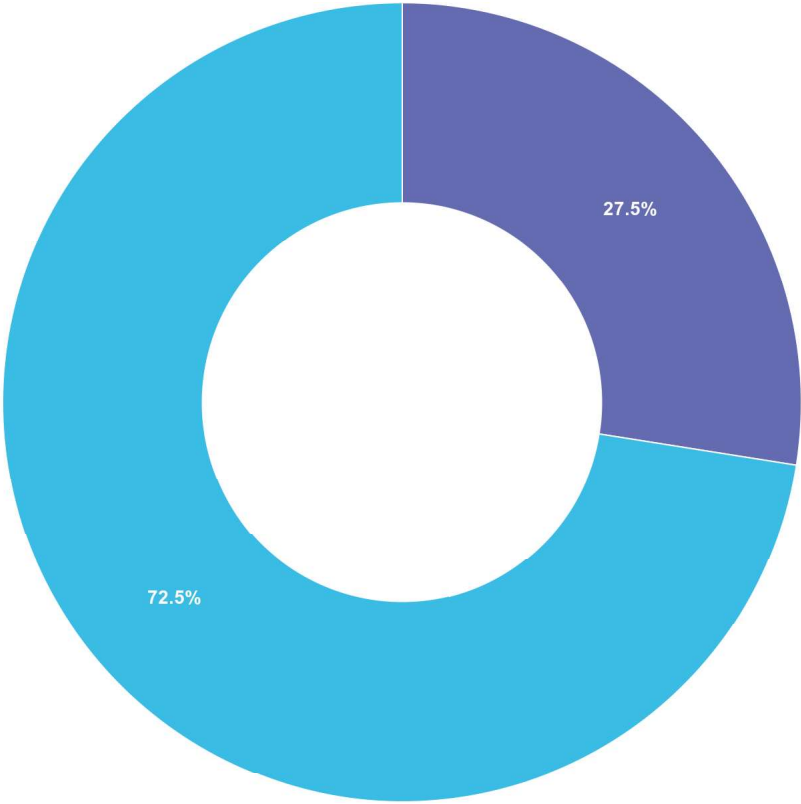

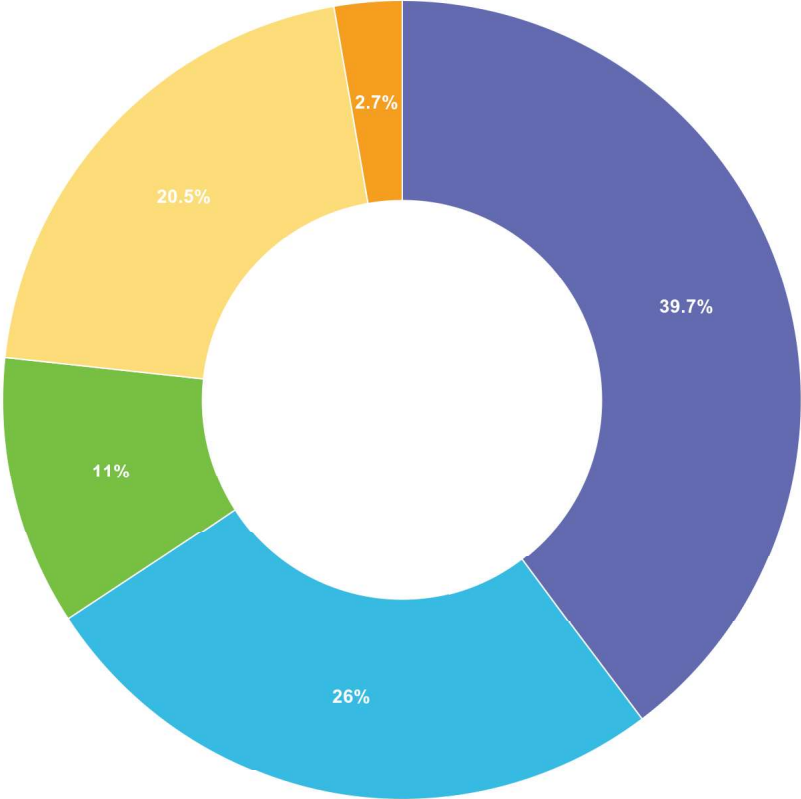

Q8 If you applied for funding, what was the total amount of your request?

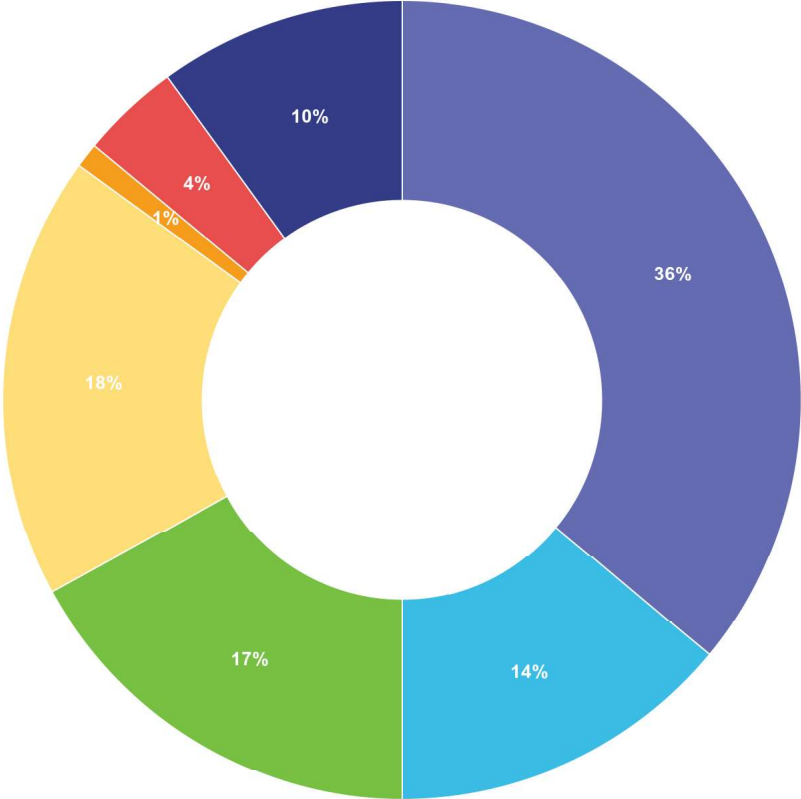
