WHEREAS, Keely Cashman, who was born in Sonora CA and resides in Strawberry CA, and;

WHEREAS, Keely Cashman learned how to ski at Dodge Ridge ski resort starting in 2001 and was on the Dodge Ridge Race team from 2005 – 2006, was a Bear Valley Race team member from 2007-2011, and was a Squaw Valley race team member from 2012-2016, and;

WHEREAS, Keely Cashman competes in Slalom, giant slalom, super-G, downhill, and combined, and;

WHEREAS, Keely Cashman made her World Cup debut in January of 2017. She competed in the 2020 World Junior Alpine Skiing Championships where she won a bronze medal in the combined discipline, and;

WHEREAS, Keely Cashman qualified for the 2021 FIS Alpine World Ski Championships but missed the competition due to injury, and;

WHEREAS, Keely Cashman represented the United States of America at the 2022 Winter Olympics where she finished 27th in the super-G and 17th in the downhill making her the top American finisher, and;

WHEREAS, in recognition of Keely Cashman’s Olympic Accomplishments Dodge Ridge ski resort will be naming a portion of their facility the KEELY CASHMAN RACE CENTER.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Supervisors, County of Tuolumne, State of California, hereby recognize the dedication, grit, and ultimate determination by Keely Cashman to be a world-class Olympian skier and recognize her impressive achievements at the 2022 Olympic games in Beijing China and;
